DATA PRIVACY POLICY

A. DEFINITION

- 1. **Visitor** means any individual or organization accessing the Website.
- 2. **Personal Information** means all personal information provided by Visitor, collected and stored by An Law, upon accessing Website, includes, but not limited to name, number phone, and email of Visitor.
- 3. Website means https://anlaw.vn, which is legally owned and managed by AN LAW FIRM (hereinafter referred to as "An Law").

B. SCOPE

- 1. This Data Privacy Policy ("**Privacy Policy**") sets out the conditions and terms relating to the collection, storage, use, and protection of Person Information of Visitor, upon accessing the Website.
- 2. This Privacy Policy comes into effect from the time posted on the Website, and may be partially or wholly modified, added, replaced, canceled at the discretion of An Law, from time to time by posting on the Website.
- 3. By accessing the Website, the Visitor agrees that he/she has read, understood, and accepted the entire content of this Privacy Policy, and entirely agreed to provide such Personal Information to An Law.
